**ENVIRONMENTAL IMPACT STATEMENT:** The long awaited 2014 DRAFT EIS, which requests that 36 more Growlers be added to the 82 Growlers currently based at NASWI, will be published mid November, 2016. No firm date as yet. WHAT HAPPENED TO ALL OUR COMMENTS IN THE 2015/15 SCOPING PROCESS???

"Scoping, an open process involving the public and other Federal, state and local, agencies, commences to identify the major and important issues for consideration during the study." OUR COMMENTS HELPED TO IDENTIFY THE MAJOR ISSUES WHICH ARE THEN STUDIED AND INFLUENCE THE "DRAFT EIS".

### WHAT IS A DRAFT EIS???

"The draft EIS provides a detailed description of the proposal, the purpose and need, reasonable alternatives, the affected environment, and presents analysis of the anticipated beneficial and adverse environmental effects of the alternatives."

NEXT STEP: "Following a formal comment period and receipt of comments from the public and other agencies, the FEIS (Final Environmental Impact Statement) will be developed and issued.
